("Giveaway")

OFFICIAL GIVEAWAY RULES

1. NO PURCHASE NECESSARY.

2. DATES: Giveaway begins on September 6, 2022 and will end September 13, 2022. All entries must be received by PTC by 11:59 p.m. Eastern Standard Time on September 13, 2022. For purposes of these Official Rules, all times are Eastern Standard Time (EST). Sponsor will not verify receipt of entries. Automated entries are prohibited, and any use of such automated devices or programs will cause disqualification.

3. ELIGIBILITY: Open to legal residents of the 50 United States (and the District of Columbia), Canada (excluding the province of Quebec) and the United Kingdom (collectively, the "Territory") who are 21 years of age or older.
